one coat at a rate of 1 gal./25 ft<sup>2</sup> per coat to yield an average total thickness of 66 wet mils or 35 DFT or,

one coat at a rate of 1 gal./40 ft<sup>2</sup> per coat to yield an average total thickness of 75 wet mils or 40 DFT.

• **Modified Bitumen**: Apply one coat at a rate of 1 gal./30 ft<sup>2</sup> per coat to yield an average total thickness of 57 wet mils or 30 DFT or,

one coat at a rate of 1 gal./25 ft<sup>2</sup> per coat to yield an average total thickness of 66 wet mils or 35 DFT or,

one coat at a rate of 1 gal./40 ft<sup>2</sup> per coat to yield an average total thickness of 75 wet mils or 40 DFT.

• **TPO (Aged)**: Apply one coat at a rate of 1 gal./30 ft<sup>2</sup> per coat to yield an average total thickness of 57 wet mils or 30 DFT or,

one coat at a rate of 1 gal./25 ft<sup>2</sup> per coat to yield an average total thickness of 66 wet mils or 35 DFT or.

one coat at a rate of 1 gal./40 ft<sup>2</sup> per coat to yield an average total thickness of 75 wet mils or 40 DFT.
